If your request for a debriefing is received within the three (3) business days deadline, we will provide the debriefing within five (5) business days upon receipt of your request. If we are unable to provide the debriefing within this period, the Standstill Period shall be extended by five (5) business days after the date that the debriefing is provided. If this happens, we will notify you and confirm the end date of the extended Standstill Period.

The debriefing may be in writing, by phone, video conference call, or in person. We shall promptly advise you in writing how the debriefing will take place and confirm the date and time.

If the deadline to request a debriefing has expired, you may still request a debriefing. In this case, we will provide the debriefing as soon as practicable, and normally no later than fifteen (15) business days from the date of publication of the Contract Award Notice.

In summary, in requesting a debriefing/submitting a complaint:


1. You must be an 'interested party'. In this case, that means a supplier who has submitted the Request for Quotation (RFQ) in this selection process.
2. The complaint can only challenge the decision to award the contract.
3. You must submit the request for debriefing/complaint within the deadline stated above.
